

2022/23 FRA Fees and Charges Summary (Levels 2 – 4) April 2022

Fees are current as at the date published, are subject to change, and effective from August 2022 to July 2023. Fees for Higher Education courses are treated separately. Concessions are subject to eligibility and availability. An administration fee of £50 applies to applicants opting for an Advanced Learner Loan or who wish to change their application to an alternative course of study. Certain courses as given below, require the students to pay an additional £99 as materials contribution at the time of enrolment.

Deposit – All fee paying students need to pay a deposit. As stated above, for those funding their studies through an Advanced Learner Loan, deposits are set at £50; being the administration fee. For private fee paying students, the deposit payable is £350 (this includes the admin fee of £50) which will be payable within two weeks of accepting your offer, or within two weeks of registering for an online course. Confirmation of a place on the course is conditional on payments and deposits are non-refundable.
